Educational Programs - Steps of Love partners with Asistencia Integral Para Menores de Puerto Peñasco (AIM Peñasco), a Mexican civil association in Puerto Peñasco, Mexico, which develops and operates programs that empower youth through education. Steps of Love provides program and technical support, as well as financial support that funds tuition, registration, exam fees, uniforms, books, and school supplies, as well as 4 homework clubs. The 4th club, opened in 2019, is designated for middle and high school students, with over 50 attending daily. The clubs are collaborative environments located in each neighborhood offering homework help/tutoring, remediation, and a safe place to spend time after school. During 2019 the program grew from 503 to 588 youth in kindergarten through college. This includes 13 special needs students who are provided with private school tuition in order to be integrated into school alongside their peers. 98% of the students advanced to the next grade level.

Foundational Needs - Steps of Love assists AIM Peñasco in meeting the basic needs of the families and youth they serve so that these students have a better chance to succeed in school and reach their full potential. We provide financial support for up to 279 students to receive vouchers for food, transportation, and medical and dental services on an as needed basis. Transportation is also provided to special needs students in the program to attend therapy and medical appointments. Additionally, Steps of Love helps cultivate volunteers to assist with home repairs, medical and dental care, clothing/food donations, and more. In 2019 Steps of Love worked with over 300 volunteers from groups in both the U.S. and Mexico including Rotary, Kiwanis, and Lions Clubs, churches, and other advocacy groups.

The Board Chair reviewed comparable salary and benefits data for this position and proposed a range to the Board Treasurer, the Operations Committee Chair and the Governance Committee Chair (who owns an HR consulting business). Together they established and approved the final salary and benefits package. Additionally, the full Board of Directors approved these expenses in conjunction with their approval of the 2019 budget which was documented in Board minutes.
